(Revenue \$) LAZAREX CARE PROGRAM: THIS PROGRAM FOCUSES ON IMPROVING THE OUTCOME OF CANCER CARE FOR ADVANCED STAGE CANCER PATIENTS, AND THE MEDICALLY UNDERSERVED, BY IDENTIFYING FDA CLINICAL TRIAL OPTIONS, BY PROVIDING ASSISTANCE WITH OUT-OF-POCKET COSTS FOR CLINICAL TRIAL PARTICIPATION AND A TRAVEL COMPANION IF NEEDED, AND BY FACILITATING COMMUNITY OUTREACH AND ENGAGEMENT. IN 2020 WE ASSISTED 722 PATIENTS WITH THIS PROGRAM AND DESPITE COVID-19, WE EXPERIENCED AN INCREASE OF 20% IN THE NUMBERS OF PATIENTS SERVED IN COMPARISON TO 2019. WE CONTINUE TO INCREASE RACE DIVERSITY AMONG THE PATIENTS WE SERVE HAVING 25% OF PATIENTS FROM MINORITY RACE/ETHNICITY ASSISTED IN 2020, WHEN THE NATIONAL AVERAGE IS NO HIGHER THAN 5%. 28% OF ALL PATIENTS SERVED IN 2020 HAD HOUSEHOLD INCOME OF LESS THAN \$25,000.
